WATKINS, the owners of Lots One (1) to Eighty-seven (87), inclusive, Meadow-brook Homes, an Addition to the City of Omaha, Douglas County, Nebraska, and they hereby make the following covenants which are to run with the land and shall be binding on all parties, and all persons claiming under them, until June 1, 1974, at which time said Comenants shall be automatically extended for successive periods of ten years unless by vote of a majority of the then owners of the lots, it is agreed to change said Covenants in whole or in part.

or assigns shallviolate or attempt to violate any of the Covenants herein, it shall be lawful for any other person or persons owning any real property situated in said development or subdivision to prosecute any proceedings at law or in equity against the person or persons violating or attempting to violate any such covenant and either to prevent him or them from so doing or to recover a damages or other dues for such violation.

Invalidation, of any of these Covenants by judgment or Court order shall in ho wise affect any of the other provisions which shall pemain in full force and effect:

A). All lots in the tract shall be known and described as residential lots. No structures shall be erected, altered. placed, or permitted to remain on any residential building plot other than one detached single-family dwelling not to exceed two stories in height and a private garage for not more than two cars.

No building shall be erected nearer to the front let line nor nearer to the side street line than permitted by the City of Omaha, Douglas County, Nebraska. In any event, no building shall be located on any residential building plot nearer than whirty-five (35) feet to the front let line nor nearer to any side street line as provided by the City of Omaha, Douglas County, Nebraska. No building except a detached garage or other outbuildings located thirty-five (35) feet or more from the front let line shall be located nearer than five (5) feet to any side let line. No residence or attached appurtenance shall be erected on any let further than 40 feet from the front let line.

- No residential structure shall be erected or placed on any building plot, which plot has an area of less than 5,000 square feet or a width of less than 50 feet at the front building setback line.
- D) No noxious or offensive trade or activity shall be carried on upon any lot nor shall anything be done thereon which may
