

PROTECTIVE COVENANTS

These Covenants are to run with the Land and shall be binding on all present and future owners of all or any part of the real estate hereinafter described until January 1, 1985.

If said present or future owners, or any of them, or their grantees, heirs or assigns, shall violate or attempt to violate any of these Covenants, it shall be lawful for any other person or persons owning any part of said real estate hereinabove described to prosecute any proceedings at law or in equity against the person or persons violating or attempting to violate any such Covenant and either to prevent him or them from so doing or to recover damages or other dues for such violation.

Invalidation of any of these Covenants by judgment or court order shall in no way affect the validity and enforceability of any of the other provisions herein contained.

A. All lots in the addition hereinabove described shall be used only for residential purposes or for church, educational or charitable uses.

B. No structures shall be erected, altered, placed, or permitted to remain on any "residential building plot" as herein-after defined, other than one detached single-family dwelling or two-family dwelling not to exceed two and one-half stories in height and a private garage or car port for not more than two cars and attached breezeways or other out-buildings incidental to residential uses.

C. No residential structures shall be located on any residential building plot nearer than thirty-five feet to the front lot line, nor shall any structure, except a detached private garage, be located nearer than five feet to any side line of any building plot; provided however that the provisions of this paragraph shall automatically be amended pro tanto as to any lot or lots for which the Board of Appeals of the City of Omaha, Nebraska shall determine and permit a lesser set back or side yard distance.

D. No residential structure shall be erected on placed on any building plot which has an area of less than five thousand (5,000) square feet and such a plot of said minimum dimensions when used for residential purposes, is herein defined as a "residential building plot".

E. No noxious or offensive trade or activity shall be carried on upon any plot nor shall anything be done thereon which may be or become an annoyance or nuisance to the neighborhood.

F. No trailer, basement, tent, shack, garage, barn, or other outbuilding erected on said real estate shall at any time be used as a residence temporarily or permanently, nor shall any structure of a temporary character be used as a residence.
