DECLARATION OF COVENANTS AND RESTRICTIONS

Page #2 (Declaration of Covenants and Restrictions)

No automibles, trucks, motorcyles or other vehicles shall be repaired, dismantled or stored except in an enclosed structure.

All interior and exterior fences shall be constructed of quality materials in a workman like manner. No interior or exterior fences shall be constructed of barbed wire or steel fence posts. All interior fences shall be a minimum of 4 foot high. All fencing must be kept in good condition and not allowed to deteriorate or look shabby.

Any areas where livestock is maintained or kept shall be maintained at all times in a neat, clean, and orderly manner.

No obnoxious or offensive trade or activity shall be carried on upon said acreage nor shall anything be done thereon which may be or become an annoyance or nuisance to the neighborhood.

Said sub-division shall not be used whole or in part for the storage of any property or things that will cause the land to appear in shabby or untidy appearance or that is detrimental to abutting property owners.
